## 2. INTRODUCING STRONGBODY.AI: TECHNOLOGY PLATFORM & ROLE

### 2.1. We are a Connection Platform & Knowledge Marketplace

[StrongBody.ai](#) (a subsidiary of MultiMe AI) is positioned as a **Connector Platform**.

- **Role:** We act as a *Technology Provider*, delivering an infrastructure that includes a "marketplace," "digital storefronts," and "payment gateways."
- **P2P (Peer-to-Peer) Model:** Every transaction is a direct civil agreement between the Expert and the User. StrongBody acts as the connecting intermediary and does not interfere with the consultation content.

### 2.2. Participants & Operating Mechanism

The ecosystem operates based on the interaction between three core elements:

- **Providers (Experts):** Independent professionals (Doctors, Coaches, Psychologists, etc.). They participate as *Partners*, building their own brands and taking full responsibility for their consultation content.
- **Users:** The MultiMe AI member community seeking advice and solutions to improve their quality of life.
- **"Dual Role" Mechanism (Switching Roles):** Boundaries are blurred when an Expert is also a User in other fields (since expertise is finite, but needs are infinite). This creates a continuous flow of transactions and a *Win-Win* mindset.

**Connectivity Method:** The platform utilizes technology to optimize connections through *Smart Matching* (Search & Match), *Build Care Team* features, and notably, *AI Voice Translation*, which eliminates language barriers in all global consultation sessions.





## 2.3. Multi-Sector Connection Categories: Services & Commerce

[StrongBody.ai](https://StrongBody.ai) is an open platform for **ALL** experts, including both Service Sellers and Product Sellers. We categorize our operating mechanisms based on the legal nature of the goods involved to optimize business opportunities:

### 2.3.1. Health & Wellness (Specialized Mechanism)

This is a core focus area but requires strict legal compliance.

- **Services:** Nutrition consulting, Personal Training (PT), Yoga, Mental Health (Coaching), and professional consultation (Non-diagnostic).
- **Products:** For products related to health, medical supplies, and dietary supplements, the platform leverages the "Share Products" (Share & Refer) model as a key strength, sourcing directly from the expert's country of origin. This allows Experts/Product Sellers to introduce reputable products without violating international e-commerce regulations regarding the listing of health-related items.

### 2.3.2. Lifestyle & Consumer Goods (Global Business)

Sectors with fewer legal barriers, allowing for immediate market expansion.

- **Services:** Fashion consulting (Stylist), skincare, makeup, design, etc.
- **Products:** Fashion, accessories, standard cosmetics, smart home appliances, etc. Legal products that do not require special licenses can be sold immediately via *Global Sales* (Person-to-Person), reaching multinational customers.

### 2.3.3. Multi-Disciplinary Experts (Professional Freelancers)

Open to all other professional skills within society.

- **Fields:** Lawyers, Financial Experts, Marketers, Tech Engineers, Tutors, Feng Shui Consultants, Artists, etc.





- **Format:** Selling consultation hours, project execution (Freelance), or selling digital products (E-books, courses, software).

**Core Mindset:** Whether you are selling "intellect" or "merchandise," [StrongBody.ai](https://StrongBody.ai) provides the tools to convert that value into income, utilizing flexible operating mechanisms that comply with multinational laws.

  - **Health Products (Health):** The "Share Products" model helps international experts earn money from local markets without getting entangled in logistics barriers or complex import laws.

## 4. TECHNOLOGY INFRASTRUCTURE: BUSINESS OPERATING SYSTEM FOR INDEPENDENT EXPERTS (SOLOPRENEURS)

[StrongBody.ai](https://StrongBody.ai) provides a comprehensive digital platform, helping Experts transition from a freelance model to operating a professional knowledge business:

### 4.1. Digital Profile Store (Knowledge Commercialization System)

Upgrading the capability profile (Portfolio) into a complete commercial touchpoint:

- **Diversifying product categories:** The system allows for flexible listing and pricing of knowledge assets: from online consultation sessions (Live Consultation) and long-term coaching programs (Coaching) to digitized products (E-books, Video Courses).
- **Optimizing conversion:** The interface is designed with standard UX/UI to drive purchasing behavior and direct payment right on the profile, minimizing unnecessary intermediate steps.

### 4.2. "Smart Offer" Mechanism (Intelligent Solution Proposal)

Replacing the "Passive Booking" model with an in-depth service negotiation process:

- **Operational process:** The system collects input data regarding customer needs. Based on this, the Expert actively analyzes and sends a specifically designed (Tailor-made) Service Offer.
- **Collaboration efficiency:** Ensures alignment on expectations and solutions between both parties before proceeding, eliminating low-quality connections and increasing post-consultation satisfaction rates.



### 4.3. Escrow Payment Gateway

[StrongBody.ai](https://StrongBody.ai) acts as an intermediary organization ensuring Trust & Safety for cross-border transactions:

- **Guarantee mechanism:** Customers deposit 100% of the service value into the system before the consultation session begins.
- **Automatic disbursement:** Remuneration is disbursed to the Expert's account as soon as the service is confirmed complete. This mechanism completely eliminates the risk of bad debt and ensures absolute financial transparency.

### 4.4. Global Connectivity Infrastructure (Powered by MultiMe AI)

## 5. LEGAL MECHANISM & RISK MANAGEMENT

### 5.1. Disclaimer & Intermediary Role

- **StrongBody's Role:** We provide the technical infrastructure for connection. We do not control, do not interfere with, and are not responsible for the detailed content of private consultation sessions between Experts and Users.
- **Expert's Responsibility:** Experts operate as independent contractors. Any advice, regimens, or instructions given are the sole professional responsibility of the individual Expert.
- **Nature of Service:** Services on the platform are defined as "Consultation & Advisory"; they are not a substitute for medical diagnoses at hospitals or emergency cases.

### 5.2. "Self-Declaration" & "Market-Driven" Mechanism

Instead of strict entry censorship that creates difficulties for Partners wishing to open a store, StrongBody applies a management mechanism based on Transparency and User Choice:

#### *a. Right to Freedom of Business & Self-Responsibility (Self-Declaration):*

- **"Digital Premises" Model:** When Experts pay the Subscription fee to open a "Digital Store" on StrongBody, you have full authority to set up your profile, describe your experience, and list services.
- **Content Responsibility:** Experts are fully responsible before the law and customers regarding the honesty of self-declared information (Degrees, certificates, experience...). StrongBody is not responsible for verifying the accuracy of this information at the initial registration step.

#### *b. "Verified Badge" Mechanism (Optional):*



To protect privacy, Experts have the option regarding whether to publicly upload original degrees.

- **Verification Service (Optional):** StrongBody provides a "Profile Verification" (KYC) feature. Experts can voluntarily send documents to the system (kept strictly confidential). After cross-checking, the system will grant a "Verified Pro" Badge (Blue Tick) next to the display name.
- **Benefits:** Profiles with the "Blue Tick" will be prioritized by the algorithm for display and create higher trust with customers, helping to increase contact rates.

c. Review & Report System:

- **Self-purifying market:** The Expert's reputation is determined by the customers themselves through the public "Star" and "Review" system after each consultation session.
- **Violation Reporting Mechanism:** StrongBody provides a "Report" button for users. We only intervene/lock accounts when there is clear evidence of the Expert committing fraud, harassment, or serious violations of Community Standards.



## 6. PRODUCT SHOWCASE – SHARE PRODUCTS FEATURE

### 6.1. Why "Share Products"?

Unlike mass market e-commerce platforms, StrongBody does not integrate a "Buy Now" button or a shopping cart for direct payment on product posts. We position this feature with a professional approach:

- **Specialized Showcase Space:** This is where You provide information, knowledge, and the core value of the product (origin of medicinal ingredients, tool features, mechanism of action...) from a scientific and transparent perspective.
- **Reference Nature (Information Hub):** For the public and regulatory authorities, this area serves as a reference information channel, helping users discover and learn about reputable health support solutions before deciding to use them.

### 6.2. Regulations on Products and Supplementary Tools

StrongBody is a specialized platform for knowledge connection and consultation. We understand that in certain therapies (such as Oriental Medicine, Nutrition...), Experts need to provide specific tools or preparations for customers to practice.

- **Operating Mechanism:** On the StrongBody platform, You only list and collect fees for "Hea Packages (Microservices / Mini Tasks)".
- **Regarding accompanying physical products:** If the consultation process requires the use of herbs or supplementary products, the Expert can guide the Customer to purchase them locally, or recommend reputable third-party suppliers/shipping units.
- **Disclaimer:** Transportation, compliance with import/export regulations, medical licenses, and the quality of these physical products are the sole legal responsibility of the Expert towards the Customer and the authorities of the



host country. StrongBody does not participate in the inspection, pricing, or transportation of these physical products.

- Bulk Quantity Policy: In cases where partners/buyers have a need for large-scale export or import, this constitutes a separate commercial agreement outside the platform; StrongBody will not intervene in this process.
